Our Presenter

Sandra R. Klein is a judge on the United States bankruptcy court, Central District of California. She was appointed on April 22, 2011, succeeding Judge Kathleen H. Thompson. Her current term will expire on April 21, 2025. Judge Klein earned a bachelor's degree from the University of Massachusetts, a J.D. from Loyola Law School, and a master's in business administration degree from the UCLA Anderson School of Management. Prior to joining the court, Klein began her legal career as a law clerk to Judge Arthur Alarcon of the U.S. Court of Appeals for the Ninth Circuit. She then joined the law firm of O'Melveny and Myers, where she worked from 1995 to 1997. From there, Klein transitioned her practice to the public sector, where she took a position as a Special Assistant U.S. Attorney in the Office of the U.S. Attorney for the Central District of California from 1997 to 2003. She later joined the Criminal Enforcement Unit of the Department of Justice's U.S. Trustee Program, where she was employed as a bankruptcy fraud criminal coordinator from 2003 to 2009. Klein was promoted and served as acting chief of the Criminal Enforcement Unit until her appointment to the court.
